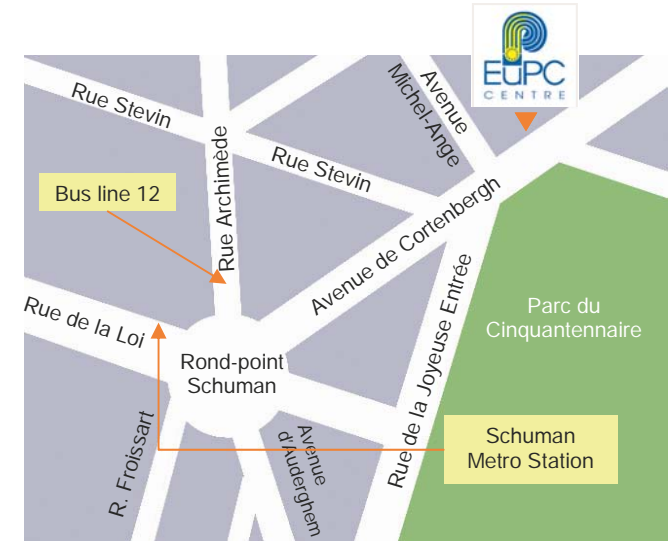
An invoice will be issued on receipt of your registration. All payments must be completed by the commencement of the workshop.

How to reach the EuPC Centre



From the airport (20-25 minutes)

- Option 1:** - Train to Bruxelles
- Get off the train at 'Gare Centrale'
- Take the metro:
Line 1a (direction Stockel)
or Line 1b (direction Hermann-Debroux)
to Schuman Station
- Option 2:** Bus Line 12 (Airport line) to Brussels-Schuman bus stop

From Schuman bus stop or metro station, walk up Avenue de Cortenbergh (2 minutes). The EuPC Centre is on the left side of the avenue.
