The conformity of this characterization will be checked according to agreed quality check procedure. All sorted PE-HD products are advised to be checked upon their recyclability according to the PRE Design for Recycling Guidelines.

Source	Indicate the market stream of the waste (see glossary)
Colour	Indicate colour (see glossary)

Impurities content (max %)	Indicate the total maximum content
Metals (max %)	Indicate the maximum content
Paper/Cardboard (max %)	Indicate the maximum content

Glossary

- **Resin:** EPS, Mixed polyolefins, PE-HD, PE-LD, PE-LD, PE-M, PET, PP, PS, PVC, Other Thermoplastics, Others.
- **Product:** Bottles \leq 5 L, Containers \leq 200 L & Drums \leq 1.000 L.
- Origin: Commercial & Industrial Waste, Commercial packaging waste Municipal waste (deposit, drop-off, kerbside collection), Other recycling systems.
- **Source:** Packaging Household, Packaging Commercial and Packaging Transport & Industry.
- **Colour:** Clear (contains up to 5% coloured), Coloured and Mixed coloured (contains more than 95% mixed & coloured PE-HD).
- Impurities content: the impurities content is the sum of all the unwanted impurities.
- Prohibited Impurities: the listed prohibited impurities should not be present in the bales.
- **Food contact:** PE-HD waste to be processed to food contact rPE-HD must be guaranteed with max. 5% of PE-HD from non-food consumer applications.
