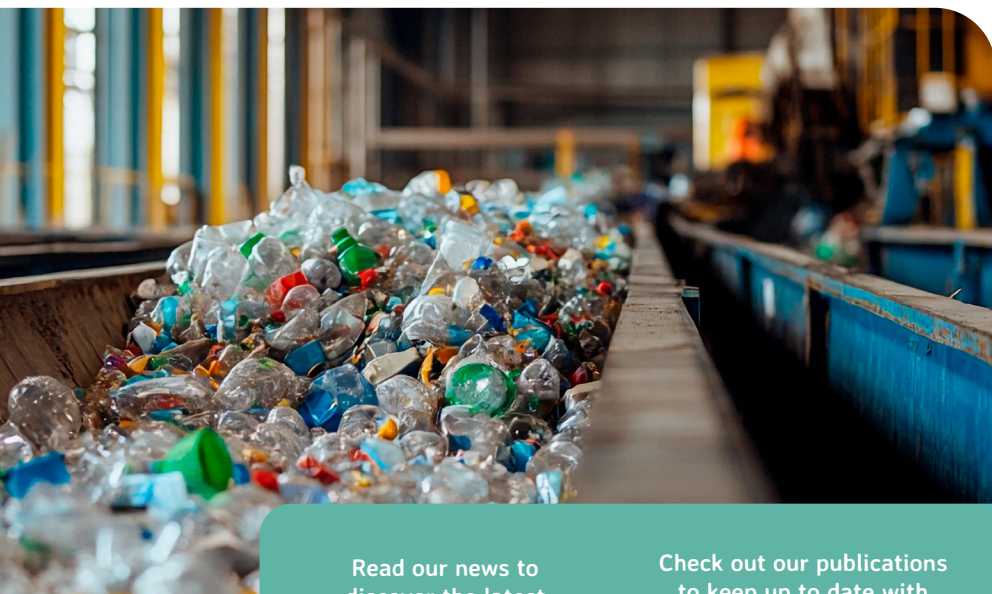

We represent our members' interests and engage directly with industry and EU stakeholders to ensure that policies affecting plastics recycling are supportive of their work.

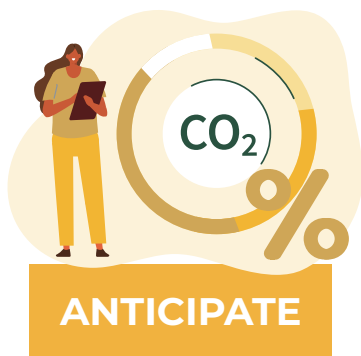

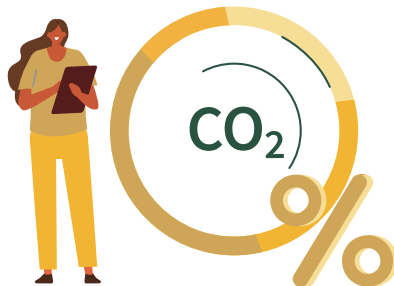
